

INTENT

Season 9 Policies

The Classes at INTENT are designed for all dancers wanting to grow in their technique and artistry in a safe environment.

Everything we do at INTENT is ELITE, SAFE, and AGE APPROPRIATE.

TUITION

\$35 - ENROLLMENT FEE

one-time, non-refundable registration fee

MONTHLY TUITION

\$60/month for one 30-minute class

\$65/month for one 45-minute class

\$75/month for one hour class

\$90/month for 75-minute class

\$105/month for 90-minute class

FAMILY DISCOUNTS

5% off - first sibling

10% off - second sibling

15% off - third sibling

5% off - military/fire/police

SHOWCASE FEES

[showcase classes *ONLY*]

\$75 - SHOWCASE FEE

one-time, non-refundable registration fee, per dancer

Due March 1st

\$100- COSTUME FEE

per showcase dance

Due December 1st

End of the year showcase date/location/times coming in September

TUTION + FEES

Tuition can be paid at the first of each month. Tuition will be paid via Freshbooks and an invoice will be emailed at the first of each month.

Program rates are based on the total season's program and what the program is offering your mover (NOT a specific number of classes within a month). Tuition has been conveniently divided into 9 equal payments.

LATE PAYMENT POLICIES:

- A 5% late fee will be applied to balances 15 days late
- A 10% late fee will be applied for balances 30 days late
- If your balance is 30 days late, your dancer will not be allowed to attend their group session until the bill is paid in full.

ATTENDANCE POLICY

100% of missed sessions due to unforeseen cancellations made by INTENT will be made up.

You may not take a month off and freeze your spot and payments. Monthly payments are for a portion of the year, not a specific month of lessons, and space is reserved for your dancer in the program for the full season. Therefore, tuition payments must be made regardless of whether your dancer attends their classes or not.

WITHDRAWAL

If your dancer withdraws from INTENT at any point you will need to submit a request before the 1st of the following month or you will be responsible for paying that month's tuition on top of your drop fees. Enrollment fees, showcase fees, and costume fees are non refundable.

INTENT

Assumption of Risk, Liability Waiver & Photo/Video Release

Participation in **INTENT** involves physical activity and carries inherent risks, including but not limited to falls, collisions, strains, or other injuries. By participating, I acknowledge these risks and voluntarily choose to participate (or allow my child to participate).

I understand that I am responsible for ensuring that I or my child(ren) are physically able to participate in all activities offered through **INTENT**. I agree to assume all risks associated with participation, whether known or unknown.

On behalf of myself and/or my child(ren), I voluntarily release, waive, discharge, and hold harmless **INTENT**, its owners, instructors, employees, volunteers, contractors, and representatives from any and all claims, liabilities, demands, damages, costs, or expenses arising from or related to participation in classes, rehearsals, performances, events, or other activities, including those resulting from ordinary negligence to the fullest extent permitted by law.

I understand that in the event of an illness, injury, or medical emergency, reasonable efforts will be made to contact the emergency contact provided. If I cannot be reached, I authorize emergency medical treatment as deemed necessary by qualified medical personnel and understand that I am responsible for any resulting medical expenses.

Photo & Video Release

I grant **INTENT** permission to photograph, film, or record me and/or my child(ren) during classes, rehearsals, performances, and studio events. I understand these images and recordings may be used for promotional, educational, and marketing purposes, including on social media, the studio website, printed materials, and other advertising, without compensation or further approval.

If I do not wish for myself or my child(ren) to be photographed or recorded, I will notify **INTENT** in writing prior to participation.
